

1. Eligibility: “Why I Love Pacific Palisades” Student Art Contest (the “Contest”) is open only to those who submit an entry to participating school administration offices. The contest is only open to legal residents of The United States of America and is void where prohibited by law. Employees of **Caruso** (the “Sponsor”) its respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state and local laws and regulations.
